FEE SCHEDULE FOR PERMIT AMOUNT:

A.

- 1) For a license to hawk, peddle or solicit on foot:
 - a) For one week or fraction thereof: \$25,
 - b) For more than one week; at the rate of \$25 per week.

- 2) For a license to hawk, peddle or solicit, other than on a seasonal basis, with a vehicle of any kind, for each vehicle:
 - a) For one week or fraction thereof: \$50
 - b) For more than one week: at the rate of \$25 per week.

- 3) For a license to hawk, peddle or solicit on foot or from a vehicle, if purchase for a season for each vehicle.
 - a) For eight weeks: at the rate of \$80.
 - b) For 10 weeks: at the rate of \$90.
 - c) For 12 weeks: at the rate of \$100.

B. Any licensee using a horse and wagon or motor vehicle may employ two persons and no more to assist in selling and delivering the wares, but such persons shall so act only while accompanying a licensed peddler, hawker or solicitor.

C. The above fees may be waived if the license is for an established and generally recognized nonprofit charitable organization. Said fees may only be waived if an application is made to the Mayor for said waiver of fees, and provided that the Mayor deems said organization an established and generally recognized nonprofit charitable organization.
