

**NOTICE IS HEREBY GIVEN** that the Board of Trustees of the Village of Rouses Point, Clinton County, New York, has on the 4th day of January 2010 passed a Resolution setting forth the Voter Registration Day for the 2010 Village Election. A copy of the complete resolution is as follows:

**RESOLUTION**

**WHEREAS** the next General Village election for Officers will be held on the 16<sup>th</sup> of March 2010, and

**WHEREAS** no person shall be entitled to vote at any Village Election whose name does not appear on the register of the election district in which he/she claims to be entitled to vote, and

**WHEREAS** it is the duty of the Inspectors of Election to prepare such register of qualified voters for the district for which they're appointed, and

**WHEREAS** the Village Officials have chosen to hold a Registration Day for the General Village Election.

**NOW THEREFORE BE IT RESOLVED THAT:**

1. The Inspectors of Election shall meet upstairs at the Village Complex at 139 Lake Street on the 9<sup>th</sup> day of February, 2010 beginning at 8:30 A.M. and ending at 4:00 P.M. to commence the preparation of the register for the forthcoming Village Election.
2. Registration for the Village shall be held on Saturday, the 6<sup>th</sup> of March 2010.
3. Such Registration shall be held at the Village Offices at 139 Lake Street, Rouses Point, NY from 12 o'clock noon until 5:00 p.m.
4. Voting for the forthcoming Village Election shall be conducted at Halstead Hall, Rouses Point Civic Center, 39 Lake Street, Rouses Point, NY. The polls will be open from the hours of 12 o'clock noon until 9:00 p.m.
5. At least ten (10) days prior to the Registration Day set in this Resolution, a copy of such Resolution shall be published in the official newspaper and a copy be posted in at least one (1) conspicuous public place in each election district.

**THIS RESOLUTION** shall take effect immediately. The question of the foregoing was duly put to a vote on roll call which resulted as follows:
