**CALL MEETING TO ORDER:**

Mayor Rivers called the meeting to order and began with the Pledge of Allegiance to the Flag.

Mayor Rivers stated that the following bid results were received for the Surplus Materials: Ed Duda - \$3.00 for the Olivetti Manual Typewriter; Phillip Favreau - \$1005.75 for the 3 metal docks; John Bernard - \$140.00 for misc. sewer, court, and police items; and Steven Provost \$51.00 for misc. sewer and water items for a total of \$1213.75 Trustee Jefferson made a motion to accept these bids; Seconded by Trustee Baker; AYE CARRIED

Mayor Rivers asked that the bids received for the Security Camera at the Library and the two (2) Electrical Reclosers be rejected. Trustee Huchro made a motion to reject these bids; Seconded by Trustee Jefferson; AYE CARRIED

Mayor Rivers announced that a press release is being published notifying the residents that during the month of November the Village Electric Crew is required to check all transformers for stray voltage. It is necessary that they open every transformer while doing this project. The crew may have to remove/trim shrubs, plants, etc. in order to gain access to some of the transformers.

Mayor Rivers stated that we have a committee for Codes Review and we need to get this going and asked that the Board to give their thoughts at the next meeting.
